2 . The period of deputation is for three years and period of loan is for two years. The period of deputation including the period in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department if the Central Government shall ordinarily not exceed three (03) years. However, the period of deputation may be extended depending upon performance of the officer as well as the

organizational requirement.

3. It is requested that this vacancy circular may be circulated within your Zone/ Directorate and willingness of the interested and eligible officers may be forwarded to this office through e-office or email (estt-nacinpsm@gov.in) in the prescribed proforma enclosed with this circular along with APAR grading of the officers for the last five years, No Objection Certificate of concerned Zonal Chief Commissioner specifically mentioning therein the mode of selection (deputation or loan basis) and Vigilance Certificate.
