- 2. The training will be a mix of theoretical sessions and case based discussions to sensitize the participants on issues involved. It is expected that at the end of the training, participants will gain a better understanding on concepts of enforcement architecture in the areas of customs and GST; investigation procedures, techniques and the legal aspects; method of Intelligence and Information gathering; how to prepare an investigation report and SCN; information about various alerts, modus operandi circulars and intelligence information systems etc.

- 5. It may be mentioned that limited hostel facilities are available for the participants, who wish to stay in campus.
