Subject: Three days Specialized Course on "Planning for Superannuation" for retiring officers of the rank of Assistant/Deputy/Joint/Additional Commissioners of Customs & Central Excise with residual service of two years or less scheduled for 23<sup>rd</sup>, 24<sup>th</sup> & 25<sup>th</sup> of January, 2017 – reg.

The National Academy of Customs, Excise and Narcotics, Faridabad is organizing three days specialization course on "Planning for superannuation" on 23<sup>rd</sup>, 24<sup>th</sup> & 25<sup>th</sup> January, 2017 for officers retiring during the year 2017 & 2018 from the rank of Assistant/Deputy/Joint/ Additional Commissioners of Customs & Central Excise Department. The above training is being organized, inter alia, to prepare them for life post retirement. This course will also cover topics on various areas like stress management, attitudinal change post retirement, Yoga and Meditation, health management, financial planning & investment for retirement, management of old age diseases, nutrition & dietary advices and other personal issues etc. that may emerge post-retirement.

- 2. It is requested that suitable officers of the rank of Assistant/Deputy/Joint/Additional Commissioners, who would be retiring during the year 2017 & 2018, working under your zone/charge, may be nominated for participating in the above course.

For the participants, the hostel and mess charges (all inclusive) shall be approximately Rs. 650/- per day. This includes Rs. 100/- room rent, Rs. 100/- Breakfast + bed tea, Rs. 200/- for dinner
