National Academy of Customs, Indirect Taxes and Narcotics, Faridabad is organizing a One-Day Training on "New GST Return System" on 09.08.2019 for Group 'A' and Group 'B' officers of CBIC.

2. The GST council in its 31st meeting has decided that a new GST Return System will be introduced to facilitate taxpayers. Hence, in order to familiarize the CBIC officers with the new returns system, NACIN is organizing **One-Day Training on "New GST Return System" on 09.08.2019 at NACIN, Faridabad**. After attending this training, the participants will have greater awareness about the nature and components of New GST Return System. They will also be better placed to steer the easy transition to the new return system and create awareness amongst the taxpayers.

3. It is, therefore, requested that suitable Group 'A' & Group 'B' officers, may please be nominated for participating in the above training.

The telephone/mobile numbers, e-mail address (in capital letters) and Employee ID of the nominated officers may also be indicated in the nomination letter so as to facilitate ease of communication and for creation of training data base of CBIC officers.

5. It may kindly be ensured that the soft copy of nomination may also be sent in word format only. It is, further, requested that the hard copy of nomination may not be sent separately through courier or by post so as to avoid wastage of paper.


6. It may kindly be ensured that the officer once nominated should attend the training course as last minute cancellation/withdrawal results in considerable administrative and financial issues.

7. It may be mentioned that limited hostel facilities are available for the participants, who wish to stay in campus. For the participants, the hostel and mess charges (all inclusive) shall be approximately Rs. 400/- per day. This includes Rs. 100/- room rent, Rs. 100/- Breakfast + bed tea, Rs. 200/- for dinner. Rs. 250/- for lunch and tea/snacks (twice a day) is to be paid separately at the time of registration by all the participants. 8. In case participants are desirous of staying in a nearby hotel, they may send their request to e-mail id: nacengangotri@gmail.com for hotel details for which booking shall be done directly by the participants.
