
2. The objective of this training is to familiarize the participants with the ICES module and Risk Management System for imports and exports and post clearance audit. In addition, there will be discussions on new/upcoming developments in ICES including Turant Customs, New Sea Cargo Manifest Regulation, objectives and benefits of RMS along with hands-on-training on Import & Export modules in ICES and in RMS. At the end of the course, the participants are expected to appreciate better how to strike an optimal balance between facilitation and enforcement; reduce dwell time without compromising revenue interests; and enhance the quality of assessment, examination and audit while effectively utilizing available resources.
3. It is, therefore, requested that suitable Group 'A' officers may be nominated for participating in the above training.
4. Nominations may please be sent through e-mail only at **email ID: nomination.istnacin@gmail.com** to Shri Ajai Kumar Arora, Deputy Director, NACIN, Faridabad by 19th August, 2019 positively. The telephone/mobile numbers, e-mail address (in capital letters) and Employee ID of the nominated officers may also be indicated in the nomination letter so as to facilitate ease of communication and for creation of training data base of CBIC officers.
5. It is further requested that hard copy of nomination may not be sent separately through courier or by post so as to avoid wastage of paper.
6. It may kindly be ensured that the officer once nominated should attend the training course as last minute cancellation/withdrawal results in considerable administrative and financial issues.
7. It may be mentioned that limited hostel facilities are available for the participants, who wish to stay in campus. For the participants, the hostel and mess charges (all inclusive) shall be

approximately Rs. 400/- per day. This includes Rs. 100/- room rent, Rs. 100/- Breakfast + bed tea, Rs. 200/- for dinner. Rs. 250/- per day for lunch and tea/snacks (twice a day) is to be paid separately at the time of registration by all the participants.
