- 2. The training will be a mix of theoretical sessions and case based discussions to sensitize the participants on issues involved. It is expected that at the end of the training, participants will gain a better understanding on concepts of enforcement architecture; will know the investigation procedures, techniques and the legal aspects; method of Intelligence and Information gathering; how to prepare an investigation report and SCN; information about various alerts, modus operandi circulars, and intelligence information systems etc.

For the participants, the hostel and mess charges (all inclusive) shall be approximately Rs. 400/- per day. This includes Rs. 100/- room rent, Rs. 100/- Breakfast + bed tea, Rs. 200/- for dinner. Rs. 250/- for lunch and tea/snacks (twice a day) is to be paid separately at the
