- 1. Tentative list of topics, which may be included in the schedule training programmes are
  - (a) Authority to tax and core principles for interpretation of taxing statutes.
  - (b) Role of Adjudicators; balancing the interests of citizens and Revenue.
  - (c) Judging skills-objectives in decision making, judicial ethics, and drafting of reasoned Orders
  - (d) Rules of natural justice and application in assessment proceedings.
  - (e) Appreciation of Evidence including Electronic Evidence.

  In view of direct relevance of these topics with Commissioner (Appeals) work, Chief Commissioners are requested to nominate Commissioner (Appeals) also for the said Course

As the size of the batch is limited to 30 only, nominations will be considered on first come first serve basis received through email only (other modes of nominations will not be considered). The telephone/mobile numbers and e-mail ids (in capital letters) of the nominated officers may also be indicated in the nomination letters so as to facilitate contact/communication. Nomination received after 15<sup>th</sup> April, 2017 will not be accepted.
- 3. The arrangement for the lodging and boarding will be made by the Academy. However, the payment of the same will have to paid by the participants themselves, which they can get reimbursed from their respective offices.

4. It may kindly be ensured that once nominated, officers do report for attending the training course as last minute cancellation/withdrawal results in considerable administrative and financial issues.
