
**Sub:** Postponement of Two-Days' Training on "Enforcement of Intellectual Property Rights (IPRs)" for Group 'A' officers of CBIC from 15-16 April, 2019 to **29-30 April, 2019**-reg.

Please refer to NACIN's letter even F.No. 1202-1431 dated 25.03.2019 on Two-Days' Training on "Enforcement of Intellectual Property Rights (IPRs)" for Group 'A' officers of CBIC at NACIN, Faridabad which was earlier scheduled on 15-16 April, 2019.

2. In view of the insufficient nominations, the above training has been **re-scheduled**. **Now this training will be held on 29-30 April, 2019 at NACIN Faridabad.**
3. CBIC has a major role in the effective enforcement of IPRs. Capacity building and creating awareness about IPRs amongst CBIC officers is a *sine-qua-non* to strengthen the IPR enforcement regime. After this training, officers will have greater awareness about legal provisions relating to enforcement of IPRs; IPR (Imported Goods) Enforcement Rules, 2007; Parallel Imports; IPR status in different countries; The Copyrights Act, 1957; The Trade Marks Act, 1999; Counterfeiting of Goods and Disposal & Destruction of infringing goods. The participants will also undergo practical training on brand identification and share various case studies on IP activities.

The *telephone/mobile numbers, e-mail address (in capital letters) and Employee ID* of the nominated officers may also be indicated in the nomination letter so as to facilitate ease of communication.
5. It is, further, requested that hard copy of nomination may not be sent separately through courier or by post so as to avoid wastage of paper.
6. It may kindly be ensured that the officer once nominated should attend the training course as last minute cancellation/withdrawal results in considerable administrative and financial issues.
7. It may be mentioned that limited hostel facilities are available for the participants, who wish to stay in campus. For the participants, the hostel and mess charges (all inclusive) shall be approximately Rs. 400/- per day. This includes Rs. 100/- room rent, Rs. 100/- Breakfast + bed tea, Rs. 200/- for dinner. Rs. 250/- for lunch and tea/snacks (twice a day) is to be paid separately at the time of registration by all the participants.
