**Sub:** One-Day Training on "Inspection, Search, Seizure and Arrest under GST Act" for Group 'A' officers of CBIC on 17<sup>th</sup> May, 2019 at NACIN, Faridabad – reg.

National Academy of Customs, Indirect Taxes and Narcotics, Faridabad is organizing a One-Day Training on "Inspection Search, Seizure and Arrest under GST Act" on 17<sup>th</sup> May, 2019 for Group 'A' officers of CBIC at NACIN, Faridabad.

2. With the increasing instances of fake invoices, bogus/fake firms, evasion of GST and wrong availment of ITC & IGST refunds being detected, it is essential for CBIC officers to properly understand the basic provisions of "Inspection, Search, Seizure and Arrest under GST Act" to safeguard Government revenue and deter evasion. It is expected that at the end of this training, officers will also be able to use these provisions properly and without compromising the rights of tax payers. They will have greater awareness about the safeguards and basic requirements to be observed during search and arrest.

3. It is, therefore, requested that suitable Group 'A' officers, may be nominated for participating in the above course. Preference may be given to officers who are working in "Anti-Evasion/ Preventive wings" of the department.

The telephone/mobile numbers, e-mail address (in capital letters) and Employee ID of the nominated officers may also be indicated in the nomination letter so as to facilitate ease of communication.

5. It is, further, requested that hard copy of nomination may not be sent separately through courier or by post so as to avoid wastage of paper.

6. It may kindly be ensured that the officer once nominated should attend the training course as last minute cancellation/withdrawal results in considerable administrative and financial issues.

7. It may be mentioned that limited hostel facilities are available for the participants, who wish to stay in campus. For the participants, the hostel and mess charges (all inclusive) shall be approximately Rs. 400/- per day. This includes Rs. 100/- room rent, Rs. 100/- Breakfast + bed tea, Rs. 200/- for dinner. Rs. 250/- for lunch and tea/snacks (twice a day) is to be paid separately at the time of registration by all the participants.
