3. The period of deputation is initially for a period of three years and can be further extended by two years (one year at a time) at the discretion of the competent authority. Only officers with minimum service tenure of three years are eligible to apply.

4. The candidates so selected for deputation against the above-mentioned posts shall be eligible for prescribed allowance(s) as per extant instructions. The selected candidate(s) will have to make his/her own arrangement for residential accommodation.

4. It may please be made clear to the willing officer that once he/she were selected, he/she will not be allowed to withdraw the same and is also expected to serve the NACIN till the expiry of deputation period.

5. In case while working in the Zonal Campus of this Directorate, the conduct and /or work of the officer are not found to be satisfactory, the officer shall be liable to be reverted and repatriated to the parent Commissionerate/ Directorate without assigning any reasons, thereof.
