All publicly accessible documents on the official NACIN website, including those in **PDF** and **DOC** formats, are available free of cost. However, physical copies are not provided free of charge.

1. Training & Personnel Information

- **Annual Training Calendar & Training Plan** – Includes schedules, nominated officers, and training topics.
- **Details of Trainings conducted by NACIN and its ZTIs/RTIs** – Covers training modules, faculty, and participation records.
- **Information on officer trainees of IRS (C&IT)** – Lists officers undergoing training.

4. RTI & CPGRAMS
