ELIGIBILITY CRITERIA FOR REGISTRATION AS SUPPLIER TO NACEN

- 1. The applicant should be a reputed supplier of the items he bids to supply to the National Academy of Customs, Excise&Narcotics.
- 2. The applicant should have made similar supplies to other Government sectors/reputed public/private organizations during the previous three years.
- 3. The applicant desirous of registering for supply of stationary/computer consumables /cleaning materials should have a minimum turnover of Rs. 10 lakhs during the previous three years.
- 4. The applicants should be duly registered with the local Sales Tax Department and copy of the registration certificate should be enclosed to the application. The applicant should enclose a copy of his PAN card and Aadhaar card.
- 5. The enclosed application should be filled legibly and the applicant should ensure that all columns in the application are filled up and the required documents are enclosed. Incomplete applications and applications without required enclosures are liable for rejection.
- 6. The registration will be for a period of one year and during the said period the supplier should ensure prompt supply of all purchase orders placed on them by the Department.
- 7. Consequent on registration of Suppliers for stationary, Computer Consumables, cleaning materials and other regular office needs, the department shall call for quotation of enlisted items from the registered suppliers for the said items and such quotations should be valid for the period of registration. However, any changes in the tax factors during the period shall be accepted by the Department.
- 8. The applications should be submitted to the Department in as sealed cover addressed to the Principal Additional Director General, NACEN, RTI, BANGALORE and Super scribed "APPLICATION FOR REGISTRATION OF SUPPLIERS"
- 9. The application should be submitted to this office before 3 PM on or before 30.4.2017. Applications received after due date shall not be considered.
- 9. The Department reserves the right to accept or reject any application or all the applications without assigning any reason.
