Their ebids must be uploaded only through the Government of India, Central Public Procurement Portal (e-procurement) website. Hard copies of the bids will not be accepted.
- 4. Last date for upload of bids: Before 11-00 AM on 21.10.2021 (Thursday) Date & time for Opening of tender by NACIN: On 22.10.2021 (Friday) after 11-05 AM
- 5. The tenderers shall sign and stamp the Technical Bid form (enclosed with this Notice) and upload them on to the Central Public Procurement Portal along with the necessary documents of proof, as required. The Financial bid shall be filled up only in the BoQ Excel file format provided along with this Tender notice in the above CPPP website. The Technical bid and Financial bid will be opened separately. Care may be taken to ensure that the Financial bid's details are not shown along with the Technical bid. In case the Financial bid is visible along with the Technical bid, the bid will be liable to be rejected.

B. Eligibility criteria to be met by the bidders & documents to be submitted:

- 1. Unless legally exempted, the contractor should be registered with GST, and should have paid their Government dues properly. Relevant documents evidencing payment of GST and Income Tax during the last two years, are to be uploaded as evidence. The bidder shall upload a copy of his PAN card/letter also.
- 2. A list of the contractor's clients with contact persons and phone numbers should also be uploaded. The eligibility of the contractor will depend on their reputation and credibility also. This Academy would be verifying the supply and service of the bidders, from their previous clients. Any adverse input received from their previous clients can result in rejection of their bid.
- 3. The firm should not have been blacklisted / terminated / debarred by any Central Government Ministry/ Department/ Organization and CPSU or come to the adverse notice of any organization. The bidder <u>should furnish the relevant Declaration</u>, <u>prescribed as Annexure IV in this tender document</u>, to this <u>effect</u>.
- 4. The successful bidder should supply the Laptop of the required brand, model and specification immediately on receipt of the Purchase Order.
- 5. When filling up the Financial bid details in the BoQ, please enter data only in the blue-coloured cells. Please ensure that the **bid amounts do not include GST**. It should also be ensured that details of this Financial bid are not visible at the time of opening the Technical bid.
- 6. When uploading documents onto the e-Procurement portal, please ensure that the memory space occupied by each uploaded document is less than 20 MB

C. General conditions

- 1. In case there is a tie in the bids whereby two or more L1 bidders have quoted the same amounts, appropriate steps, as decided by the Department, will be taken to finalise a suitable L1 bidder
- 2. If any of the prescribed conditions are not fulfilled by any tenderer or are incomplete in any respect, the said tenderer's bid is liable to be rejected.
- 3. Bidders who are black-listed or who have a history of malpractice, are barred to take part in this tendering process.
- 4. NACIN, Chennai reserves the right to cancel, postpone, withdraw the invitation for Bids without assigning any reason thereof and shall bear no liability whatsoever consequent upon such a decision, if the situation so warrants.
- 5. NACIN, Chennai reserves the right to reject any or all the tender(s) received without assigning any reason thereof and decision in this regard shall be final and binding.
- 6. Initially only the Technical Bid cover shall be opened and evaluated. If the bidder meets the qualifying criteria as specified in the bid document, and the solution

- offered by him meets the requirement of the tenderer, then the bidder shall be shortlisted for financial evaluation. Otherwise, the bid would be rejected at this stage itself.
- 7. To tender their Financial bid, tenderers are required to use only the BOQ document, which is an MS Excel file and which is part of the tender uploaded on the Central Public Procurement Portal (CPP Portal). In the said BOQ document, tenderers are required to quote the cost of the laptop computer, excluding GST.
- 8. All bidders, who upload their quotations, should inform this office by email about their participation in the bidding process. They also should inform this office about their contact details including phone number. The above information should be sent to nacin.chennai@gov.in. Failure to give this information may result in the rejection of the bid. Providing this data about the bidders would be helpful for this office to circulate uniform information to all the bidders before closing of the bid, if required.
