2. Buyer Added Bid Specific ATC

ADDITIONAL TERMS AND CONDITIONS OF THE CONTRACT

1. The Manpower outsourcing services shall be provided at office of National Academy of Customs, Indirect Taxes and Narcotics, Zonal Training Institute, Delhi located at NACIN Complex, Sector - 29, Faridabad, Haryana - 121008. Service providers should have a registered office/Branch at the Faridabad District in Haryana. Valid documentary proof of the same should be attached with the bid.
2. The Bidder must be registered with the statutory Central and State authority viz., ESI, EPF, Income Tax, GST Registration etc., and should have a valid Labour License for supply of manpower as mentioned in the tender document. All existing statutory regulations of both the State as well as the Central Governments, shall be adhered to by the contractor and all records maintained thereof shall be available for scrutiny by this Office.
3. This Office reserves the right to terminate the contract by giving 15 days' time at any time without giving any reasons whatsoever. However, for terminating Contract by the contractor, at least one-month prior Notice shall be given to the buyer.
4. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. In case any bidder is seeking exemption, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
5. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid data sheet (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

8. The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.
9. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
10. Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer along with all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.
11. Payment to all the outsourced staff will be made by the contractor by last day of each month and contractor should submit a report – personnel wise on the amount of wages paid by 5th of every month. Bills will be reimbursed by this office on providing copies of all remittance Challans /receipts of statutory levies paid in respect of EPF, ESI, GST, etc of previous month along with the claim/bill of current month., if found in order.
12. The agency will provide a list of Outsourcing Staff along with their individual EPF/ESI no. etc. In case of leave or absence of any Outsourcing Staff, the contractor will provide substitute in place of that person or otherwise wages on pro rata basis will be deducted.
13. The service provider/contractor shall not make any unauthorized deductions from the wages of the contract labour.
14. No other person except Contractor's authorized representative shall be allowed to enter this office.
15. Contractor shall be solely responsible for payment of wages/salaries other benefits and allowances to his personnel that might become applicable under any Act or Order of the Govt. This office shall have no liability whatsoever in this regard and the Contractor shall indemnify this office against any/all claims which may arise under the provisions of various Acts, Govt. Orders etc.
16. Contractor shall be directly responsible for any/all disputes arising between him and his personnel and keep this office indemnified against all actions, losses, damages, expenses and claims whatsoever arising thereof.
17. Contractor shall be fully responsible for theft, burglary, fire or any mischievous deeds done by his staff.
18. It is made clear that the engagement of the service provider does not in any way confer any right to the service provider or the persons that may be deployed by him in this office for claiming any regular or part time employment in this office or any other Govt. Office.
19. Police verification of all the out-sourced staff is the responsibility of the contractor before deputing the staff in the office.
20. The contractor shall, on award of the contract furnish the list containing names and addresses of the workmen sent to this office for duties assigned to them.
21. Bid Evaluation: (1). Bids, in respect of which EMD & EMD declaration has been

en furnished, will only be considered for technical evaluation. (2). Financial bids of technically qualified bidders will be considered for financial evaluation. (3). Subject to satisfaction of all terms and conditions of this tender, the bidder quoting the lowest rate (L1) shall be awarded the contract. If more than one bidder quotes the lowest rate, as per guidelines in GEM portal the buyer shall have two options for placement of Contract: a) Placement of contract by selection of an agency from amongst the L-1 bidders through a Random Algorithm run by GeM system or (b) Placement of contract on any one of the L-1 bidders based on any criteria as deemed fit by the Buyer with appropriate internal approvals.

22. The service provider/contractor shall be responsible for paying bonus to contract labour in the manner prescribed by the Payment of Bonus Act, 1965, subject to eligibility & shall get reimbursed from the buyer.
23. The service provider/contractor shall be responsible for paying wages to contract labour at rates not less than the minimum wages as notified by the Appropriate Government.
24. Mandatory contribution of EPF and ESIC should be done in timely manner.
25. As per the Contract Labour (Regulation and Abolition) Act, 1970, the service provider/contractor shall be responsible for ensuring that wages are paid to the contract labour on time. The principal employer/buyer shall ensure that the wages are paid on time to the contract labour by the service provider/contractor. In case the service provider/contractor fails to pay the wages on time or makes short payment, the principal employer/buyer shall be liable to pay the wages to the contract labour directly and recover the amount from the service provider/contractor.
26. The service provider/contractor shall be responsible for paying proportionate gratuity to contract labour who have rendered continuous service as per the provisions of the Payment of Gratuity Act, 1972.
