2. This post will be filled up on loan basis from amongst the officers working under GST & Customs formations and from amongst officers holding analogous posts in the Directorates under CBIC in the same pay scale.

3. The period of loan is initially for a period of two years and can be further extended for one year at a time at the discretion of the Competent Authority with the concurrence of the Cadre Controlling Authority (CCA) concerned. Further, as per Board F. No. A-11013/12/2019-Ad IV dated 27.05.2020, in exceptional circumstances, for justifiable reasons, the Board may extend the tenure of the officers beyond 03 years.

4. Applications of interested officers may be forwarded by the CCAs to the ADG, NACIN, ZC, Shillong, at email id [nacin.shillong@gov.in](mailto:nacin.shillong@gov.in) in the proforma mentioned in the Annexure-1 along with APAR grading up to the previous 03 years, Vigilance Clearance Certificate and “No Objection Certificate” from the concerned CCAs within 45 days from date of issue of this circular. Advance copies of the applications, without NOC from the Zonal CCAs, will not be considered.

5. In case, the work and conduct of the officer is not found to be satisfactory, the officer can be reverted to the parent organization even before completion of the loan period.

6. The officers selected will continue to draw their salary and other allowances from their parent organization, as per applicable rules and Training allowance (24% of Basic Pay).
7. It is requested that this notice may be widely circulated amongst the eligible officers under your jurisdictions.
